Wood Burners Check List

What we need to know:

- Make and Model of Woodburner & Installation instructions
- Make and Model of Flue & Installation instructions
- Is it Ministry for Environment approved in the Waimakariri District? And is it approved for your property size? (www.mfe.govt.nz/standards/woodburners)

- Floor plan showing where the heater is sited in the room in relation to windows and doors. The floor plan must be scaled or dimensioned.

- Smoke detectors (where they are placed in the building)
All smoke detectors must be installed prior to final inspection and must be fitted with the “ Hush” Button facility
NB: Must be three meters from every sleeping space and in the escape route.

- Details on the Fire location
 - Distance from walls
 - Distance from windows and curtains (if any)
 - Distance from Doors*See Fire Site example over page*

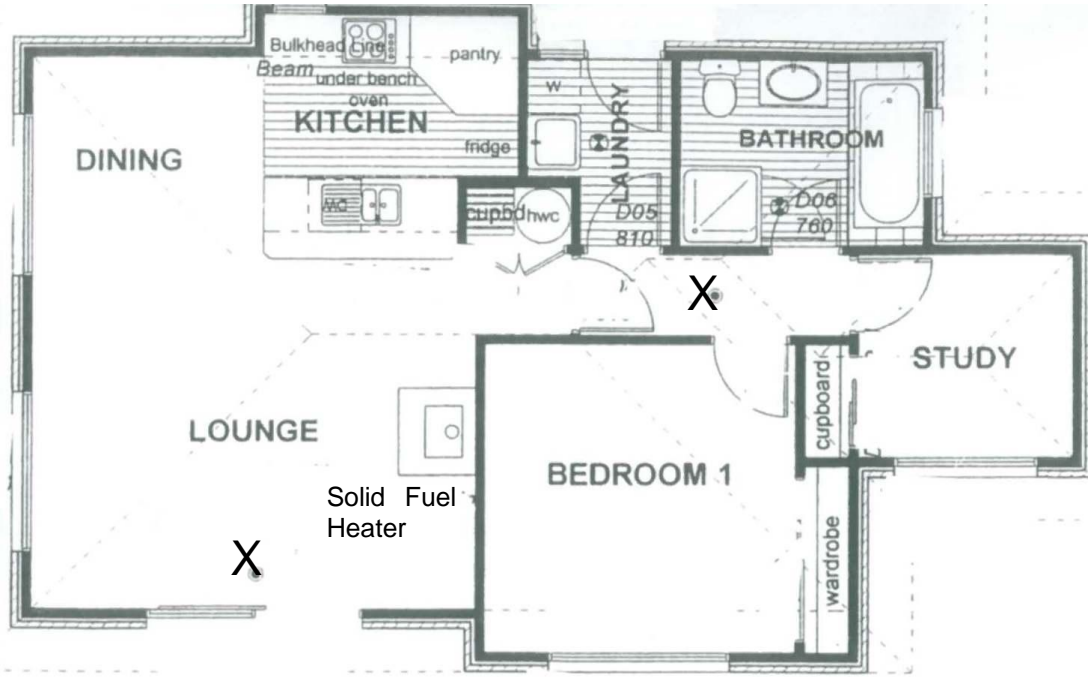
