# PROPOSED PRIVATE PLAN CHANGE P07 – Ravenswood Developments Limited, North Woodend (Business 2)

### Proposed Private Plan Change P07 – Ravenswood Developments Limited, North Woodend

Proposed Private Plan Change P07 has been initiated by Ravenswood Developments Limited seeking to rezone 1241 Main North Road and part of 1211 Main North Road and 45 Wards Road, Woodend, being Lot 10 DP 923, Lot 2 DP 327014 and Lot 11 DP 923, from Rural to Business 2. The rezoning covers an area of approximately 10 hectares approximately 1 kilometre to the north of Woodend and to the west of the Pegasus town access road. To enable this, proposed Private Plan Change P07 introduces an Outline Development Plan to the District Plan, amendments to the associated planning maps and amendments to Issues; Objectives; Policies; explanations; Methods; principal reasons for adopting Objectives, Policies and Methods; Rules and clauses. The changes proposed are:

- Amendments to Planning Maps 35 and 125;
- Insert new Outline Development Plan 158;
- Amend Issue 3.5; Objective 3.5.1; Policy 3.5.1.1 and associated explanation; Methods 3.5.1.1.2, 3.5.1.1.4 and 3.5.1.1.5, and principal reasons for adopting Objectives; Policies and Methods 3.5.2;
- Amend Policy 8.2.1.7 and associated explanation; Method 8.2.1.7.2; and principal reasons for adopting Objectives, Policies and Methods 8.2.2;
- Amend Policy 11.1.1.8 and associated explanation; and Methods 11.1.1.8.1 and 11.1.1.8.4;
- Amend the explanation to Policies 13.1.1.1 and 13.1.1.4;
- Amend the explanation to Policy 15.1.1.1;
- Amend the explanation to Policy 16.1.1.1; Method 16.1.1.1.2; Policy 16.1.1.2; principal reasons for adopting Objectives, Policies and Methods 16.1.2; Issue 16.2; and principal reasons for adopting Objectives, Policies and Methods 6.2.2;
- Amend Rule 31.18.1.4;
- Add new clause(s) to Rule 32.1.1.15;
- Amend Rule 32.1.1.26.

Any person may make a submission on a Plan Change. Submissions must be in writing and in the prescribed form (Form 5) in the Resource Management (Forms) Regulations 2003 or similar. Forms are available from the Council Offices listed above and on the Council's website.

Once all submissions have been received, the Council will prepare and publicly notify a summary of the submissions. All the submissions will be available for public inspection. There will be an opportunity for anyone to make a further submission in support of, or in opposition to any of these

submissions. Council hearings will then be arranged to consider all submissions, and decisions will be made. Anyone who has made a submission will have the right to attend the hearings and present his or her submission. Generally, anyone who has made a submission also has the right of appeal against a Council decision to the Environment Court.

*Note: That from the date of notification the changes will not have effect under section 9 of the Resource Management Act 1991 and is subject to submissions and will not be in full effect until it is made operative.*

Submissions will close at 5.00 p.m. on Tuesday 21 April 2009 at any Council office listed above. Submissions may also be lodged on the correct form via the Council's website.
