Executive Summary

- 1. This report considers submissions received by the District Council as territorial authority in relation to existing designations ('designations') and notices of requirement for new designations ('requirements') in the Proposed Plan lodged by requiring authorities **other** than the District Council. This report outlines recommendations in response to the issues that have emerged from these designations and requirements and submissions on them.
- 2. A separate report by an independent planning consultant will deal with designations and requirements lodged by the District Council as requiring authority and submissions on them.
- 3. There are 90 designations and requirements in the Proposed Plan from 10 requiring authorities **other** than the District Council. 55 of these are 'roll overs' of existing designations from the Operative Plan into the Proposed Plan without modification, 31 are roll overs of existing designations with modification, and 4 are requirements for new designations over existing facilities.
- 4. There were 8 submissions and 10 submission points relating to these designations or requirements. Five of the eight submissions received were from requiring authorities submitting on their own designations or requirements. Three submission points sought retention of designations or requirements as notified. Six submission points also sought retention of designations or requirements, albeit with requested amendments seeking minor technical corrections to matters such as designation purpose, legal description, address, and mapping of designation boundaries. One submission point was from a requiring authority seeking retention of a definition in the Proposed Plan as notified that is also a National Planning Standards definition, with the definition forming the purpose of a designation by that requiring authority to be rolled over with modification.
- 5. All submissions and submission points are recommended to be accepted and I have recommended amendments to the designations and requirements to address matters raised in submissions. The recommended changes are set out in **Appendix A** of this report.
- 6. Recommended responses to each submission / submission point, and reasons, are set out in **Appendix B** of this report.
- 7. Recommendations made in respect of the designations and requirements, and reasons, including those receiving no submissions, are set out in **Appendix C Tables 1 to 3** of this report.
- 8. Having considered the designations and requirements (other than those for the District Council), related submissions, and the matters set out in section 171 of the RMA, I recommend the following:
 - a. **No recommendation or decision be made** on existing designations rolled over from the Operative Plan into the Proposed Plan without modification and on which no submissions were received, as set out in section 2.1.2 and Appendix C Table 1 of this report, and these designations be included in the Proposed Plan;
 - b. Designations and requirements be:
 - i. **confirmed** as set out in Appendix C Table 2 of this report;
 - ii. **modified** as set out in Appendix C Table 3, and Appendix A, of this report.

1 Introduction

1.1 Purpose

- 9. The purpose of this report is to provide the Hearings Panel with a summary and analysis of the existing designations ('designations') and notices of requirement for new designations ('requirements') in the Proposed Plan lodged by requiring authorities **other** than the District Council, and submissions received on them by the District Council as territorial authority, and make recommendations with respect to the designations and requirements.
- 10. A separate report by an independent planning consultant will deal with designations and requirements lodged by the District Council as requiring authority and submissions on them.
- 11. This report is prepared under section 42A of the RMA.
- 12. This report discusses the submissions received on designations and requirements following notification of these at the same time as notification of the Proposed Plan, and concludes with recommendations with respect to whether the designations or requirements should be confirmed or modified.
- 13. The recommendations are informed by evaluation undertaken by the author.
- 14. This report is provided to assist the Hearings Panel in their role as Independent Commissioners. The Hearings Panel may choose to accept or reject the conclusions and recommendations of this report and may come to different conclusions and make different recommendations, based on the information and evidence provided to them by requiring authorities and submitters.

1.2 Author

- 15. My name is Neil Lindsay Sheerin. My qualifications and experience are set out in **Appendix D** of this report.
- 16. My role in preparing this report is that of an expert planner.
- 17. The scope of my evidence relates to designations and requirements in the Proposed Plan lodged by requiring authorities **other** than the District Council and submissions on them. I confirm that the issues addressed in this statement of evidence are within my area of expertise as an expert planner.
- 18. I note that during the course of the District Plan Review I have provided advice regarding designations and requirements to the District Council in its roles as both territorial authority and requiring authority. However, this advice has generally been restricted to explaining or clarifying technical aspects of designations, outline plans, the requirement for designation process, and the Hearing process.
- 19. Although this is a District Council Hearing, I have read the Code of Conduct for Expert Witnesses contained in the 2023 Practice Note issued by the Environment Court. I have complied with that Code when preparing my written statement of evidence and I agree to comply with it when I give any oral evidence.

- 20. Any data, information, facts, and assumptions I have considered in forming my opinions are set out in the part of the evidence in which I express my opinions. Where I have set out opinions in my evidence, I have given reasons for those opinions.
- 21. I have not omitted to consider material facts known to me that might alter or detract from the opinions expressed.

1.3 Key Issues in Contention

- 22. There are no issues in contention.
- 23. There are 90 designations or requirements in the Proposed Plan from 10 requiring authorities **other** than the District Council. 55 of these are 'roll overs' of existing designations from the Operative Plan into the Proposed Plan without modification, 31 are roll overs of existing designations with modification, and 4 are requirements for new designations over existing facilities.
- 24. There were 8 submissions and 10 submission points relating to these designations or requirements.
- 25. Five of the eight submissions received were from requiring authorities submitting on their own designations or requirements. Three submission points sought retention of designations or requirements as notified. Six submission points also sought retention of designations or requirements, albeit with requested amendments seeking minor technical corrections to matters such as designation purpose, legal description, address, and mapping of designation boundaries. One submission point was from a requiring authority seeking retention of a definition in the Proposed Plan as notified that is also a National Planning Standards definition, with the definition forming the purpose of a designation by that requiring authority to be rolled over with modification.
- 26. I address the submissions received in section 3 of this report.

'Primacy'

- 27. In October 2023 the Hearings Panel requested future s42A reports include an assessment of any potential implications that may arise should objectives in the Strategic Directions chapter of the Proposed Plan be given 'primacy' over Chapter objectives and policies, or not, and that this be carried out in accordance with the approach set out in Mr Buckley's memorandum dated 29 September 2023 (refer Minute 11, 2 October 2023, paragraph 8).
- 28. For the purposes of this report, no primacy assessment has been undertaken as I do not consider this relevant in the context of designations, as designations override other district plan provisions.

1.4 Procedural Matters

29. At the time of writing this report there have not been any pre-hearing conferences, clause 8AA meetings or expert witness conferencing in relation to submissions on the designations.

2 Statutory Considerations

2.1 Resource Management Act 1991

- 30. The Proposed Plan has been prepared in accordance with the RMA and in particular, the requirements of Clause 4 of Schedule 1, 'Requirements to be inserted prior to notification of proposed district plans'.
- 31. When reviewing a district plan Clause 4 (1A) and (1B) of Schedule 1 requires the District Council to invite requiring authorities that have an existing designation in an operative district plan that has not lapsed to give written notice to the District Council stating whether the requiring authority requires the designation to be included in its proposed district plan, with or without modification (commonly known as 'roll overs', or existing designations 'rolled over' from an operative plan into a proposed plan). Under clause 4(4) of Schedule 1, if a requiring authority does not respond to the District Council's invitation, the designation is not included in the proposed district plan.
- 32. On 15 July 2020 the District Council as territorial authority sent letters to requiring authorities with designations in the Operative Plan, and publicly advertised, notifying the opportunity for requiring authorities to advise whether they wished to roll over any existing designations from the Operative Plan into the Proposed Plan, with or without modification. This closed on 4 September 2020.
- 33. The District Council as territorial authority sent letters on 23 October 2020 to requiring authorities with designations in the Operative Plan, and publicly advertised on 31 October 2020, notifying the opportunity for requiring authorities to lodge notices of requirement for new designations to be included in the Proposed Plan. This closed 18 December 2020.
- 34. The submission process on designations and requirements ran at the same time as the submission process on all other content in the Proposed Plan.
- 35. The requirements for recommendations and decisions on designations and requirements in the Proposed Plan are set out in Clause 9 of Schedule 1:
 - 9 Recommendations and decisions on requirements
 - (1) The territorial authority shall make and notify its recommendation in respect of any provision included in the proposed district plan under clause 4(5) to the appropriate authority in accordance with section 171 or section 191.
 - (2) The territorial authority shall make its decision on provisions included in the proposed district plan under clause 4(6) in accordance with section 168A(3) or section 189A(3), as the case may be.
 - (3) Nothing in this clause shall allow the territorial authority to make a recommendation or decision in respect of any existing designations or heritage orders that are included without modification and on which no submissions are received.
- 36. Consideration of the designations and requirements must take into account the matters set out in section 171 of the RMA.

2.1.1 Section 171 Recommendation by Territorial Authority

- 37. Section 171 of the RMA states:
 - (1A) When considering a requirement and any submissions received, a territorial authority must not have regard to trade competition or the effects of trade competition.
 - (1) When considering a requirement and any submissions received, a territorial authority must, subject to Part 2, consider the effects on the environment of allowing the requirement, having particular regard to—
 - (a) any relevant provisions of—
 - (i) a national policy statement:
 - (ii) a New Zealand coastal policy statement:
 - (iii) a regional policy statement or proposed regional policy statement:
 - (iv) a plan or proposed plan; and
 - (b) whether adequate consideration has been given to alternative sites, routes, or methods of undertaking the work if—
 - (i) the requiring authority does not have an interest in the land sufficient for undertaking the work; or
 - (ii) it is likely that the work will have a significant adverse effect on the environment; and
 - (c) whether the work and designation are reasonably necessary for achieving the objectives of the requiring authority for which the designation is sought; and
 - (d) any other matter the territorial authority considers reasonably necessary in order to make a recommendation on the requirement.
 - (1B) The effects to be considered under subsection (1) may include any positive effects on the environment to offset or compensate for any adverse effects on the environment that will or may result from the activity enabled by the designation, as long as those effects result from measures proposed or agreed to by the requiring authority.
 - (2) The territorial authority may recommend to the requiring authority that it—
 - (a) confirm the requirement:
 - (b) modify the requirement:
 - (c) impose conditions:
 - (d) withdraw the requirement.
 - (2A) However, if the requiring authority is the Minister of Education or the Minister of Defence, the territorial authority may not recommend imposing a condition requiring a financial contribution (as defined in section 108(9)).
 - (3) The territorial authority must give reasons for its recommendation under subsection (2).

38. For new requirements, and roll overs of existing designations with modification, the provisions of section 171 of the RMA apply. Accordingly, I have considered the new requirements, roll overs of existing designations with modification, and the submissions received on them, in section 3 of this report. I have provided recommendations and reasons (including recommended responses to the submissions received) for the Hearings Panel's consideration in section 4 of this report. Additional details of the submissions and the reasons given for the recommendation in response to those submissions are set out in **Appendix B** of this report.

2.1.2 Rolled Over Designations

- 39. In accordance with Clause 9(3) of Schedule 1 of the RMA, where an existing designation has been rolled over from the Operative Plan into the Proposed Plan without modification and no submissions are received, the rolled over designation must be included in the Proposed Plan. In these instances, the District Council as territorial authority does not make a recommendation to the requiring authority.
- 40. The existing designations rolled over from the Operative Plan into the Proposed Plan without modification and on which no submissions have been received, and on which no recommendation (by the territorial authority) or decision (by the requiring authority) need be made, are as follows:

2.2 Trade Competition

- 41. Trade competition is not considered relevant to the designations in the Proposed Plan.
- 42. There are no known trade competition issues raised within the submissions.

3 Consideration of Designations, Requirements and Submissions

3.1 Designations and Requirements in Proposed Plan

- 43. There are 90 designations or requirements in the Proposed Plan from the following 10 requiring authorities **other** than the District Council:
 - a. Chorus NZ Ltd (CNZ);
 - b. Hurunui District Council (HDC);
 - c. KiwiRail Holdings Ltd (KRH);
 - d. Minister of Corrections (MCOR);
 - e. Minister of Education (MEDU);
 - f. Mainpower NZ Ltd (MPNZ);
 - g. Minister of Police / NZ Police (MPOL);
 - h. NZ Transport Agency Waka Kotahi (NZTA);
 - i. Spark NZ Trading Ltd (SPK); and
 - j. Transpower NZ Ltd (TPR).
- 44. 55 of these are roll overs of existing designations from the Operative Plan into the Proposed Plan without modification, 31 are roll overs of existing designations with modification, and 4 are requirements for new designations over existing facilities.

3.2 Submissions Received

- 45. There were 8 submissions and 10 submission points from the following, relating to the designations or requirements in the Proposed Plan:
 - a. Ara Poutama Aotearoa Department of Corrections;
 - b. Drucilla Kingi-Patterson;
 - c. KiwiRail Holdings Ltd;
 - d. Mainpower NZ Ltd;
 - e. Minister of Education;
 - f. Minister of Police / NZ Police;
 - g. NZ Transport Agency Waka Kotahi;
 - h. Z Energy Ltd.
- 46. Five of the eight submissions received were from requiring authorities submitting on their own designations or requirements namely, the parties listed in paragraph 45 c. to g. above. Three submission points¹ sought retention of designations or requirements as notified. Six submission points² were from requiring authorities also seeking retention of their designations or requirements, albeit with requested amendments seeking minor technical corrections to matters such as designation purpose, legal description, address, and mapping of designation boundaries.

47. One submission point³ sought retention of the Proposed Plan definition of 'community corrections activity' as notified. The definition of 'community corrections activity' is a National Planning Standards definition. The definition 'community corrections activity' forms the designated purpose of the only Corrections designation in the Proposed Plan, MCOR-1. This is a roll-over of an existing designation, with modification to the designated purpose, changing it from 'periodic detention and probation reporting centre' to 'community corrections activity', with the modification included in the Proposed Plan as notified. No submissions were received on MCOR-1.

3.3 Recommendations

- 48. As all the submission points received are in support, or in support with only minor technical amendments requested, all submissions and submission points are recommended to be accepted and I have recommended amendments to designations and requirements to address matters raised in submissions.
- 49. Recommended amendments to designations and requirements are set out in **Appendix A** of this report.
- 50. Recommended responses to each submission / submission point, and reasons, are set out in **Appendix B** of this report in **submission point order**.
- 51. Recommendations made in respect of designations and requirements, and reasons, including those receiving no submissions, are set out in **Appendix C Tables 1 to 3** of this report in **requiring authority prefix and designation number order**.

4 Conclusions

- 52. All submissions and submission points are recommended to be accepted and I have recommended amendments to designations and requirements to address matters raised in submissions as set out in **Appendix A** of this report.
- 53. Recommended responses to submissions on the designations and requirements, and reasons, are set out in **Appendix B** of this report.
- 54. Recommendations made in respect of the designations and requirements, and reasons, including those receiving no submissions, are set out in **Appendix C Tables 1 to 3** of this report.
- 55. I consider the designations and requirements, with the recommended amendments, will be the most appropriate means for achieving the objectives of the requiring authorities for which the designations and requirements are sought.

Recommendations:

- In accordance with Clause 9(3) of Schedule 1 of the RMA, no recommendation or decision be made on existing designations rolled over from the Operative Plan into the Proposed Plan without modification and on which no submissions were received, as set out in section 2.1.2 and Appendix C Table 1 of this report, and these designations be included in the Proposed Plan;
- 2. In accordance with Clause 9(1) of Schedule 1 and section 171(2)(a) of the RMA, the territorial authority recommend to the relevant requiring authority that it **confirm** its designations and requirements, as set out in Appendix C Table 2 of this report; and
- 3. In accordance with Clause 9(1) of Schedule 1 and section 171(2)(b) of the RMA, the territorial authority recommend to the relevant requiring authority that it **modify** its designations and requirements, as set out in Appendix C Table 3, and Appendix A, of this report.

- d. include but not be limited to the provision of academic, sporting, social and cultural education including through:
 - i. formal and informal recreational, sporting and outdoor activities and competitions whether carried out during or outside school hours;
 - ii. formal and informal cultural activities and competitions whether carried out during or outside school hours;
 - iii. the provision of specialist hubs and units (including language immersion units and teen parenting units) for children with particular educational requirements or special needs.
- e. enable the use of facilities for purposes associated with the education of students including school assemblies, functions, fairs and other gatherings whether carried out during or outside school hours.
- f. enable the provision of associated administrative services; carparking and vehicle manoeuvring; and health, social services and medical services (including dental clinics and sick bays).
- g. enable housing on site for staff members whose responsibilities require them to live on site (e.g. school caretaker) and their families.

(Minister of Education Designations Definition)

<u>"Education Purposes" for the purposes of these designations shall, in the absence of specific conditions to the contrary:</u>

- i. Enable the use of the facilities on the designated site by and for the educational benefit of any school age students (i.e.: years 0 to 13) and early childhood children regardless of whether they are enrolled at any institution located on that designated site.
- ii. Enable the provision of supervised care and study opportunities for students outside school hours in school facilities


