

RESOURCE MANAGEMENT ACT 1991 PROPOSED WAIMAKARIRI DISTRICT PLAN VARIATION 2: FINANCIAL CONTRIBUTIONS

NOTIFIED: 13 August 2022

Waimakariri District Council invites you to make a submission on Variation 2: Financial Contributions, pursuant to Clause 5 of Schedule 1 of the Resource Management Act 1991 (RMA).

Variation 2: Financial Contributions is a variation to the Proposed District Plan in respect of financial contributions. Financial contributions may be collected on resource consents or permitted activities to fund upgrades to infrastructure, such as roading and the supply of drinking water, wastewater and stormwater, or to offset adverse effects on the environment. Financial contributions can be a payment of money, land, or a combination of these.

The Council proposes to amend the Proposed District Plan to include new objectives, policies, rules and standards in the Financial Contributions Chapter, and a consequential amendment to Part 1 of the plan. The new provisions in the Financial Contributions Chapter state which activities require financial contributions, and the method for calculating these.

Submissions close at 5.00 p.m. on Friday, 9 September 2022.

Once submissions have closed, the Council will prepare and publicly notify a summary of the submissions. All the submissions will be available to view online. There will be an opportunity for certain persons to make a further submission in support of, or in opposition to, any of these submissions.

Hearings on the submissions to the variation will occur in conjunction with the hearings on the Proposed District Plan in early-to-mid 2023. Anyone who has made a submission will have the right to attend the hearings and present their submission should they wish to do so. Generally, anyone who has made a submission also has the right of appeal against a Council decision to the Environment Court.
