Good morning Audrey,

We write in response to Minute 4 and advise that Christchurch International Airport Limited (submitter 254) do not oppose a separate hearing stream for submissions that relate to the Airport Noise Contour and Bird-strike. CIAL will abide by the direction of the Hearings Panel.

If the Panel is minded to establish an additional hearing stream, CIAL will seek to clarify its attendance at other chapter hearings. For example, CIAL has submissions relating to policies and objectives in the Energy and Infrastructure chapter which do not explicitly relate to the Air Noise Contours / Bird-strike. If it would be of assistance, we can prepare a memorandum which sets out CIAL's submissions / further submissions and the hearing stream we think they fit best.

Furthermore, we are hoping to clarify administrative matters set out in Minute 1. Paragraph 118 directs that speaking time is to be confirmed by submitters 10 working days prior to the relevant hearing. However, the latest notice of hearing for stream 4 requests that speaking time is confirmed by 22 June, which is 15 working days prior to the hearing. We would be grateful if you could please let us know which timeframe we should proceed with.
