Dear Commissioners,

Proposed Waimakariri District Plan - Hearing Stream 8 (Subdivision - Rural and Residential)

KiwiRail Holdings Limited (**KiwiRail**) is the State-Owned Enterprise responsible for the management and operation of the national railway network. This includes managing railway infrastructure and land, as well as rail freight and passenger services within New Zealand. KiwiRail is also the Requiring Authority for land designated "Railway Purposes" in District Plans throughout New Zealand.

KiwiRail generally supports the Council Officer's recommendations contained in the Section 42A Reports for Subdivision (Rural) and Subdivision (Residential). The Council Officer accepted a number of KiwiRail's submission points on this topic and these submission points are not discussed further in this statement.¹

The Section 42A Reports make recommendations on KiwiRail's submission points that were not wholly accepted or were rejected. I have provided responses to these recommendations in the table attached to this letter as **Attachment 1**.

KiwiRail does not wish to be heard at the hearing. However, I am available to answer any questions from the Hearing Panel either in writing or via videoconference if required.

KiwiRail is seeking appropriate reverse sensitivity policies in other Chapters of the Proposed Plan and on that basis, will not pursue the relief sought for the Subdivision Chapters further.
