During the presentation of the case for Bellgrove Rangiora Ltd at the Stream 10A Hearing earlier this week, the Chairperson inquired whether the decision of Commissioner Caldwell in relation to Plan Change 69 to the Selwyn District Plan was subject to any appeals to the Environment Court. We have investigated the matter and can advise as follow.

PC69 was appealed by Lincoln Voice Incorporated on 4 August 2022. The appeal raises several issues and in broad terms opposes the Council decision to approve PC69. The Selwyn District Council has advised that the proceeding remains extant.
