

① Flooding. I personally think that the neighbouring farmer has not been honest to the Rolleston Industrial Development LTD. Flooding has become more aggressive since the Kaikoura earthquake in 2016.

In 2016 our property has dropped in land area about 4 inches in some parts of our section to eight inches.

I've had to personally fill 12 trailer's loads of soil to build it up. Every year since then 8-12 trailer loads. Our top soil keep being washed away due to flooding on the south end of our property. About 10 metre straight through.

③ In 2016 Our property has dropped since then flooding as increased bit by bit until the last 3 years has escalated. I have given photos of the last year's submission I now have photos to prove it has got worse in July 23rd 2023 two weeks ago. The volume of water is colossal. The fire brigade came out about 3am in the morning. When I came outside to see what was going on I put my gumboots on and to my surprise walking to the gate meeting the fireman my gumboots filled up with water. It was hard to walk back. My gumboots were 2-3 inches below my knee. Two months ago we made a whare to stop water flow from Paddock up about 1/2 metre high against the fence line of the pine-
