RESOURCE MANAGEMENT ACT 1991 PUBLIC NOTIFICATION OF APPLICATION FOR A RESOURCE CONSENT

The Waimakariri District Council has received the attached application for a resource consent from Longmead Downs Limited, 425 Loburn Kowai Road Loburn North.

Proposal

To subdivide 425 Loburn Kowai Road, Loburn North (legally known as Lot 2 DP 559709) into 16 lots that are 4.0 hectares or larger. The property has an area of 77.76 hectares. The subdivision will be undertaken in 4 stages. Proposed Lots 2 - 12 would be served by a new accessway from Loburn Terrace Road, and Lots 13 - 17 would be served by a new accessway from Loburn Kowai Road.

All lots achieve the required minimum area of 4ha and the required minimum dimensions of 120m x 120m for a suitable shaped allotment under the Operative District Plan. All proposed lots are less than the required minimum area of 20ha under the Proposed District Plan.

Land use consent is also sought to allow for the future establishment of a residential dwelling on the proposed lots, which are undersize under the Proposed District Plan, as well as an additional minor dwelling unit on proposed Lot 17.

The application is a Discretionary activity under the Waimakariri Operative District Plan and a non-complying activity under the Proposed District Plan. The site is located in the Rural Zone (Waimakariri Operative District Plan) and General Rural Zone (Waimakariri Proposed District Plan)
