### **Notification of the Summary of 24 Additional Submission Points and a call for Further Submissions on the 24 additional submission points on the Proposed Waimakariri District Plan**

**Notification: 30 March 2023**

After the close of the further submission consultation on the Waimakariri District Plan review on 21 November 2022, the Council has identified several submission points either incorrectly summarised or missed within the original summary of submissions. The Council has corrected these affected submission points. Further submission consultation on these submissions is open now.

Affected parties have an opportunity to comment in support of or opposition to these specific submissions. The further submission process is not a call for new submission points or topics. A further submission can only be made on these affected submissions.

#### **Who can make a further submission?**

The following persons may make a further submission:

- A person who has an interest greater than the public in general.
- A person representing a relevant aspect of the public interest.
- The local authority itself (Waimakariri District Council).

Note: Further submissions must be submitted on a form that meets the requirements of Form 6 of the Resource Management Act 1991 within 10 working days from the date of this notice. This form is available in different methods as below.
