## **Dear Hearing Commissioner**

## Fire and Emergency New Zealand - Letter to be tabled for Proposed Waimakariri District Plan -

Fire and Emergency New Zealand (Fire and Emergency) made a submission on the Proposed Waimakiriri District Plan: Te orooro | Noise, Pūngao me te hanganga hapori | Energy and Infrastructure and Ranga waka | Transport Chapters. Fire and Emergency have opted not to attend the hearing scheduled to commence from the 21 – 25 August 2023 and request that, in lieu of attendance, this letter be tabled for the Hearing Commissioners' consideration.

## Fire and Emergency's Submission

Fire and Emergency made a number of recommended changes to the Proposed Waimakiriri District Plan. The s42A report for the Te orooro | Noise, Pūngao me te hanganga hapori | Energy and Infrastructure and Ranga waka | Transport Chapters The relief sought by Fire and Emergency and the officer's recommendations are outlined in Table 1 below.

As indicated in Table 1, Fire and Emergency were agreeable to majority of the definitions, objectives, policies and rules that were proposed with the Proposed Waimakiriri District Plan: Te orooro | Noise, Pūngao me te hanganga hapori | Energy and Infrastructure and Ranga waka | Transport chapters.



Fire and Emergency sought amendments to the definition of Emergency Service and Standard 4 of the Transport chapter. A further amendment sought the inclusion of a definition for ".

The reporting officer has accepted all of the relief sought by Fire and Emergency except for the inclusion of emergency service training activities as a definition. However, it is considered that emergency service training activities could be undertaken in accordance with permitted activity rules and under the definition of emergency service facilities. As such, no further relief with respect to emergency service training activities is required. However, if emergency service training activities do not fall within the definition of emergency services facilities then Fire and Emergency reiterate their original submission point requesting the inclusion of a separate definition relating to emergency service training activities.

## Fire and Emergency Response

Fire and Emergency support the recommendations by the reporting officer in relation to Fire and Emergency's submission points subject to the clarity sought above.
