Section 219, Sale and Supply of Alcohol Act 2012

Applicant notes and information

If you are wanting to apply for a Manager's Certificate, you must be currently working in licensed premises.

The District Licensing Committee (DLC) requires a minimum of six months' experience working in licensed premises and evidence that the applicant has recent, relevant experience in the control of licensed premises.

To lodge this application you will need:

- The prescribed fee of \$316.25. The fee is non refundable
- Completed application
- A copy of your Licence Controller Qualification certificate (LCQ) completed for the Sale and Supply of Alcohol Act 2012 or an LCQ Bridging Test if you completed your LCQ under the Sale of Liquor Act 1989

Note: The Bridging Test enables managers to show they understand and can comply with the new Act

- Two current references including a letter from the employer of the licensed premises where you are working
- Club Manager's Certificates will no longer be renewed under SSAA
- Club Managers must complete the designated training course to upgrade to a Manager's Certificate. Required is a copy of your course certificate and a letter from the club you are working at, showing your involvement.

The Licensing Inspector will contact you to arrange a suitable time for an interview.

Note:

- Failure to provide references as to your character and/or experience and proof of knowledge of the Act will delay the processing of your application. An affidavit may be accepted if no references can be provided.
- Incomplete applications will not be accepted. An exception may be made if the applicant has been appointed as a Temporary Manager (Section 130 notification).

Please do not return this information sheet with your application.

Privacy Statement

Information contained in your application and any supporting information will be held by Waimakariri District Council to enable your application to be processed under the Sale and Supply of Alcohol Act 2012. The Council may provide information contained in this application to Immigration New Zealand for the purpose of verifying your immigration status. This information includes:

- The start date of any visa granted to you
- The expiry date of any visa granted to you
- The date on which you were granted entry permission
- The conditions, if any, relating to your immigration status
- Any changes to your immigration status, and the dates of the changes
- Any action taken under the Immigration Act 2009 in relation to you, and the date of the action.

The information will be provided to the statutory reporting agencies (the Police and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Waimakariri District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Waimakariri District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available. The Council is required to keep a record of every Manager's application filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors and the Police for the purposes of monitoring ongoing compliance with any Manager's Certificate conditions and undertakings, Duty Manager appointments, and the Act. The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority. Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act you have the right to see and correct personal information that the Council holds about you.

Processing Timelines

Applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application.

Notes for Manager's Certificate

- Where the applicant is presently employed at a licensed premises, this application should be filed with the District Licensing Committee for the district in which the applicant is employed. In all other cases, it should be filed with the District Licensing Committee for the district in which the applicant is residing.
- In order for your application to be processed quickly and efficiently, we require the following information to be submitted with your application:

Overseas residents seeking to work in New Zealand should provide a photocopy of their passport details including work visa

The prescribed application fee of \$316.25.
