Mayor Gordon thanked the staff for the considerable amount of work that had gone into producing these Activity Management Plans and for having them completed in time for the Long Term Plan process.

### 4.2. <u>Draft Long Term Plan 2021 – 2031, Draft Consultation Document, Draft</u> <u>30 Year Infrastructure Strategy and Draft Financial Strategy – J Palmer</u> (Chief Executive)

J Millward presented the report, noting that though the preparation of the documentation had involved a significant amount of work, he considered this to be one of the best Long Term Plan budget processes he had been involved in over many years. The proposed rate increase in the draft Long Term Plan was 3.95%, and throughout the ten years, it was proposed that the increases would not be more than 4.2%. Staff had endeavoured to smooth out the proposed increases over the allotted time period. An audit had been conducted on the Consultation Document with the Auditors providing clearance for the adoption of the Consultation Document. J Millward explained that once the consultation had been undertaken on the Long Term Plan and all submissions heard and considered by the Council, the Auditors would undertake a thorough audit of the primary 2021/2031 Long Term Plan document.

Mayor Gordon commented that an extensive number of workshops had been held during the Long Term Plan process, which assisted in streamlining the budget processes. He was pleased that the Council had shown restraint during this time of uncertainty in the community due to the Covid-19 pandemic and was proud of the document being presented to the community for consultation. Mayor Gordon expressed a concern regarding the 24% rate increase proposed by Environment Canterbury (ECan); advising that he had raised the Council's concerns directly with the Chairperson of ECan.

Councillor Atkinson remarked on the invaluable briefings that had been provided to Councillors which had assisted in the decision making by the Council. He believed that this Long Term process was one of the best that he had been involved with and complimented staff on the work that had been undertaken. Councillor Atkinson emphasised that it was important that the flow of information continued.
