The relevant proceedings

The Environment Court's reference number for the proceedings is ENV-2025-CHC-71.

The parties to the proceeding are Andrew McAllister & Survus Consultants (McAllister) and the Waimakariri District Council (Council).

The nature of the proceedings is an appeal of the Council's decision that declined the submission by Andrew McAlister & Survus Consultants seeking rezoning of land at Swannanoa to Large Lot Residential Zone (**LLRZ**) in the Waimakariri Proposed District Plan (**Proposed Plan**).

Status of party giving notice

The Prossers have an interest in the proceedings that is greater than the interest that the general public has because they made a submission on the Proposed Plan seeking rezoning of their land at Mandeville to LLRZ. The subject matter of the McAllister appeal includes management of wastewater constraints in the Mandeville/Swannanoa area, which directly affects the Prossers' property at Mandeville and future development plans for that property.

Trade competition

The Prossers are not a trade competitor for the purposes of section 308C or 308CA of the Resource Management Act 1991.

Interest in proceedings

7 The Prossers are interested in all of the proceeding.

Issues

- 8 The Prossers are interested in the following particular issues:
 - (a) Whether wastewater constraints should preclude rezoning of land to LLRZ in the Mandeville/Swannanoa area.

Relief sought

9 The Prossers support the relief sought by the McAllister appeal because they consider that resolving wastewater constraints at Mandeville/Swannanoa can be developer-led rather than waiting for the Council to act.

Dispute resolution

The Prossers agree to participate in mediation or other alternative dispute resolution of the proceedings.
