## 6. **PORTFOLIO UPDATES**

### 6.1 **Roading – Deputy Mayor Philip Redmond**

#### Focus areas for staff:

- Dig-outs and pavement repairs were continuing ahead of winter, assisted by the continuing unusually dry weather.
- Crushing metal ahead of remetalling of unsealed roads was being undertaken
- Asphalt resurfacing work had been completed on Percival Street / Victoria Street and also Tram Road / Island Road.
- Designs were about to begin for 2026/27 projects.

#### Roading Capital Projects:

- The Kaiapoi to Pineacres Cycleway construction was continuing. The contractor was currently working at the northern end of the path near the Kaiapoi Lakes. All work was due to be completed in July 2026.
- Kerb and Channel replacement work was progressing on Akaroa Street, Kaiapoi. Work was continuing on the western side of the road.
- Kerb and Channel replacement work was nearing completion on Seddon Street, Rangiora.
- Lees Valley – the installation of the concrete ford was progressing well. The concrete base had been poured and drift decks installed. Concrete was now curing.
- Installation of the electronic school variable speed signs was well progressed. Work had also begun on installing the static signs. All new speed limits were being loaded into the National Speed Limit Register. The new signs would remain covered until the speed limits come into effect. Communication was being prepared and would be shared ahead of the speed limits coming into effect. Now in the process of confirming the activation date.
- New Zealand Transport Agency (NZTA) funding confirmed for the next phase of the Rangiora Eastern Link project.

### 6.2 **Drainage, Stockwater and Three Waters (Drinking Water, Sewer and Stormwater) – Councillor Tim Fulton**

#### Drinking Water

- The Domain Road Bore 3, which supplied both Oxford Urban and Oxford Rural 2, had been successfully commissioned and was now operational.
- Mandeville bore development work on Bore 3 and Bore 4 on Two Chain Road had not been as successful as anticipated in terms of yield. A report would be brought to the Utilities and Roothing Committee in August to confirm next steps.

#### Wastewater

- Percival Street, Rangiora sewer main project was successfully completed ahead of schedule. Further on-site work was proposed for the next financial year to connect the newly installed laterals to the private sewer systems.
- The upgrade of inlet screens at Kaiapoi, Woodend, Waikuku Beach and Oxford Wastewater Treatment Plants (WWTPs) was on schedule for completion by the end of June.
- Desludging works at the Kaiapoi WWTP had commenced and were due for completion in August 2026.
- Tree removal work at the Kaiapoi WWTP had progressed well. The next step was to install a bund, which would be completed by the end of June 2026, and planting was proposed for July 2026.

- Staff were currently planning an Elected Member visit to the Kaiapoi WWTP; dates for this visit were yet to be confirmed.

Drainage / Stockwater

- Mandeville Resurgence Drainage Upgrade Stage 1A was progressing well and was due for completion by the end of June 2026; however, it may extend into July 2026. Flow and groundwater monitoring sites were proposed for installation shortly to assist with optioneering for the Stage 2 works.

**6.3 Solid Waste– Councillor Niki Mealings**

- Trialling battery disposal at Kaiapoi Service Centre in a purpose-built disposal container which has a built-in fire extinguisher. Batteries the main cause of fires in rubbish trucks.
- Larger batteries can still be taken to the transfer station at Southbrook, which also has a purpose-built battery disposal container for smaller batteries.
- Request that this information be widely circulated and advertised so residents know where and how to dispose of their batteries, including toothbrushes, watches, etc.
