## **DELEGATIONS**

- An Authorised Officer under Section 174 and an Enforcement Officer under Section 177 of the Local Government Act 2002, for the purposes of any offence under this Act, including offences against bylaws made under this Act. The Enforcement Officer
  - may seize and impound property that is not on private land in accordance with the conditions stated in Section 164;
  - has power of entry for enforcement purposes under Section 172,
  - may under Section 178 require certain information if it is believed that an offence under this Act has been committed; and
  - has power of entry to any land or buildings (but not a dwellinghouse) for the purpose of checking utility services under Section 182.
- 2. An authorised person for the purposes of Section 128 of the Health Act 1956.
