For the Attention of the Hearings Panel – Waimakariri Proposed District Plan – Hearing Stream 10A.

Transpower New Zealand Limited ("Transpower") writes in relation to the Waimakariri Proposed District Plan ("PDP"), and Hearing Stream 10A –Development Areas (noise contour, bird strike and growth policies), due to commence on 19 February 2024.

This is the fifth hearing of interest to Transpower on the PDP, with evidence lodged by Transpower to Hearing Streams 1-5. With respect to Hearing Stream 10A, Transpower lodged three submission points on the notified Development Area provisions. Given the broadly supportive nature of the S42A recommendations in response to Transpower's relief, Transpower does not intend to appear before the Panel and provide evidence. Rather, it respectfully requests that this letter be tabled for the Panel's consideration, to confirm its position in relation to its submission points and the Section 42A Report recommendations.

There is one outstanding matter that Transpower wishes to draw to the Panel's attention. In relation to the SBK - Southbrook Development Area (Transpower submission point 195.113), paragraph 209 of the S42A report generally supports Transpower's relief seeking amendments to the advisory note and the outline development plan (ODP). However, the recommendation does not explicitly state that the ODP should be amended to show the location of the National Grid. Transpower assumes that the recommendation intends to show the National Grid in a manner consistent with the S42A report "discussion", but this should be clarified.

Attachment A to this letter outlines the relief sought by Transpower, the S42A recommendations, and Transpower's response.

It is noted that the 'Doncaster ODP' shown in Figure 1 above, shows a 'No Build Area' (light blue hatching) applying over the area traversed by the transmission lines and surrounding it.
