LEGAL SUBMISSION ON BEHALF OF MOMENTUM LAND LIMITED REGARDING STREAM 10A FUTURE DEVELOPMENT AREAS

- These submissions are filed on behalf of Momentum Land Limited

 (Momentum) in respect of the Stream 10A hearing of submissions on the

 Proposed Waimakariri District Plan (Proposed Plan) and Variation 1 to the

 Proposed Plan (Variation 1) dealing with Future Development Areas.
- The Momentum submissions seek to rezone the land identified at Figure 1 of Momentum's submission on Variation 1 (shown below) to Medium Density Residential Zone (the **Momentum land**).



- Momentum also seeks to amend the Kaiapoi Outline Development Plan as shown in Appendix 3 of the Momentum submission on Variation 1.
- The Momentum submission is discussed briefly in the s42A Report for Future

 Development Areas.¹
- The s42A Report also refers to submissions by Jolly, Revell, Charles and Rose seeking various outcomes if land is rezoned in the Kaiapoi Development Area.²
- The purpose of these submissions is to advise the Hearings Panel that

Momentum plans to present evidence and legal submissions at the Stream 12 (large-scale rezoning) hearing.

- At this hearing Momentum will present its case in support of rezoning the Momentum land and associated changes to the Kaiapoi ODP. Momentum will also respond to the submissions by Jolly, Revell, Charles and Rose insofar as that may be required.
