I am President of the Northern A & P Association which owns and manages the Rangiora show grounds. We are a voluntary organisation charged with providing a community facility.

We support most of the detail contained in the new plan which refers to the show grounds. Activities as detailed in item 1 a-g are all things which the showgrounds are used for and will continue to be used. However 1c has an exclusion labeled as "f" which excludes major sports facility. Outside of the show ground the use is for sports facilities. The grounds are set up for tournaments and have been used on numerous occasions as a sporting facility.

We have sports teams use the grounds for football, rugby and we consider polo as a major sport. Therefore this exclusion is completely outside and in contradiction to the current use and on going approvals. The WDC are actively trying to find more sports teams to use the facility as it offers good conditions for sports in the winter.

The grounds are also used for Rangiora high school rugby training.

Several equestrian events are held each year which we consider to be sport. We have the springton trophy coming to our grounds in the next couple of years which we consider a major event.
