1. Introduction

This is a submission on the Proposed Waimakariri District Plan 2021 (PWDP) by the Minister of Police/NZ Police ("the Minister") which has been prepared in accordance with Clause 6 of Schedule 1 of the Resource Management Act 199 ("RMA or "the Act").

The Minister confirms she could not gain an advantage in trade competition through this submission.

This submission is of a specific nature and relates to the provisions contained within Part 3-Area specific matters, Minister of Police designations.

2. Background

The Minister of Police is a Requiring Authority as defined in Section 166 of the Resource Management Act 1991 (RMA). Designation of existing and proposed police station sites is a technique used nationally by the Minister. It provides an effective method of ensuring the Minister's and the New Zealand Police's interests in a site are protected. Specifically, the Minister is interested in the provisions of District Plans as they relate to New Zealand Police sites.

The Minister and NZ Police have three police stations located within the Waimakariri District. These stations are in Oxford, Kaiapoi and Rangiora. All these police station sites are existing and are currently designated within the Operative Waimakariri District Plan.

The Minister supports the roll over and inclusion of the New Zealand Police designations within the PWDP.

3. Specific Provisions to which the Submission relates to

This submission specifically relates directly to the Minister of Police's Tutapa-Designation for Kaiapoi Police Station (MPOL-2), 149 Williams Street, Kaiapoi, with further details outlined below.

4. Submission Statement

The Minister **supports** the roll over and inclusion of the Minister of Police designations for Oxford Police Station (MPOL-1), Kaiapoi Police Station (MPL2) and Rangiora Police Station (MPOL-3) in the PWDP.

The rolled over Designation MPOL-2 has a minor error where the land area specified in the schedule is incorrect and requires **modification**. The designation currently states 1,015m² whereas the land area for the designation (MPOL-2) at 149 Williams Street, Kaiapoi, should be 742m². This will accurately represent the land area of the designated site, 149 Williams Street, Kaiapoi.

The land area for the adjoining parcel of land at 147 Williams Street, Kaiapoi has been incorrectly included in the land area calculation for the Kaiapoi Police Station designation (MPOL-2).

The legal description of the designation is correct and likewise the planning maps are correct.

5. Relief Sought

The Minister seeks the following decision from the Waimakariri District Council of the Proposed Plan:

- (a) That the land area for the designation for the Kaiapoi Police Station (MPOL-2) have the land area **modified** to correctly state 742m² rather than 1,015m² as currently shown in the Minister of Police/NZ Police designation. The extent of the required amendment is shown in **Annexure 1.**
- (b) Such further or consequential relief as may be necessary to fully give effect to the relief sought in this submission.

6. The Minister wishes to be heard in support of her submission.
