Submission to Waimakariri Proposed District Plan

Thank you for the opportunity to submit.

OSZ - OPEN SPACE ZONE – Good Street Reserve, Rangiora

The Council is proposing the introduction of Open Space Zones. These are not a feature of the current operative District Plan. The Rangiora Museum, which is operated by the Rangiora and Districts Early Records Society Inc, is located in a proposed Open Space Zone at the Good Street Reserve, Rangiora. The building is owned by the Waimakariri District Council.

The Museum is listed as a permitted activity at OSZ-R12 Cultural Facility.

We note that the Council is proposing a wide range of controls and discretions at OSRZ-MCD1 to ORSZ-MCD14 and, bearing in mind that the Council is also the landowner, we see the range as understandable. However, we share the Reserve with Rangiora Bridge Club and the northern section of one of the Rangiora Bowling Club's greens, as well as the open space and playground. It is important to us that decisions relating to the reserve involve all parties and we would like to see that written into either the District Plan or into Council Policy. For example, the three organisations share an entrance off Good Street, a driveway and parking space.

The Society supports the proposed creation of this zone but notes that the rules of the Zone have the potential to affect the operations of the Rangiora Museum. As our landlord, however, the Council has not communicated specifically any implications of this new zoning to the Society.
