#### ADDENDUM TO SUBMISSION

- 1. They do not provide a minimum site size for either 2 or 3 residential units of up to 3 storeys high. Whilst there are standards relating to site coverage, building height etc., it is considered inappropriate to permit, (as of right), such building on small residential sites.
  - Without Council having the ability to impose a minimum site size, and which also allows for provision of appropriate services including parking and green spaces, towns such as Rangiora could end up with pockets of "high rise ghettos" with the attendant social problems that are often found in such areas.
- 2. They do not provide any requirement to provide garaging or off street parking for said residential units. Currently most residential properties have 2 vehicles (many have more), therefore it is not unreasonable to suggest that 3 residential units on a site could have at least 6 vehicles, with no requirement for provision of off street parking. Apart from the obvious road congestion and potential for increased vandalism to vehicles, there are the important issues of emergency and waste management services access that need to be considered and allowed for.
- 3. Will permit, as of right, residential development that is out of character for the town of Rangiora and other towns in the Waimakariri District.
