The Board owns land in the NER - North East Rangiora Development area. That land is currently used for educational purposes, specifically for equine, agriculture and horticulture education.

We note that the educational use of land in the NER is provided for in the proposal.

The proposal states at Appendix DEV-NER-APP1 - North East Rangiora Outline Development Plan that there are two options for the land use of land owned by the Board and surrounding land. Land use for medium density residential will not be compatible with the Board's educational purposes and it is noted that other possible land use designations are provided for in the proposal that will be consistent with the Board's objectives.

The Board is generally supportive of the proposed change of land use in the NER North East Rangiora Development area. The changes are seen as positive for the wider community that the school serves.

However, the Board is concerned about the increasing amounts of reverse sensitivity from surrounding land owners towards the Board's agricultural activities that are essential for its educational purposes. These are risks that can be managed through carefully planned development activities and by ensuring that the amount of land able to be used for educational purposes is not reduced under whichever of the options is found to be preferred.

The Board looks forward to continued dialogue over the implementation of the options proposed.
